

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Civic, Military, & Veterans Affairs.

HB25-1315 be amended as follows:

1 Amend printed bill, strike page 13 and substitute:

2 "(b) A CANDIDATE COMMITTEE ESTABLISHED IN THE NAME OF A
3 CANDIDATE WHO IS RUNNING FOR A MAJOR POLITICAL PARTY VACANCY
4 ELECTION MAY ACCEPT FROM ANY ONE PERSON THE AGGREGATE
5 CONTRIBUTION LIMIT SPECIFIED IN SECTION 3 (1) OF ARTICLE XXVIII OF
6 THE STATE CONSTITUTION APPLICABLE TO THE OFFICE THE CANDIDATE IS
7 SEEKING AT ANY POINT DURING THE ELECTION CYCLE FOR THE MAJOR
8 POLITICAL PARTY VACANCY ELECTION HELD PURSUANT TO SECTION
9 1-12-203 (1.5).".

10 Page 14, strike line 1.

11 Page 14, line 3, strike "portion and (2.5)(a); and substitute "portion,
12 (2)(a)(I)(C), (2)(a)(I)(D), and (2)(a)(I)(F);".

13 Page 14, after line 7 insert:

14 "(C) On the first day of each month beginning the sixth full month
15 before the major election; except that no monthly report shall be required
16 on the first day of the month in which the major election OR MAJOR
17 POLITICAL PARTY VACANCY ELECTION CONDUCTED PURSUANT TO SECTION
18 1-12-203 (1.5) is held;

19 (D) On the first Monday in September and on each Monday every
20 two weeks thereafter before the major election OR MAJOR POLITICAL
21 PARTY VACANCY ELECTION CONDUCTED PURSUANT TO SECTION 1-12-203
22 (1.5);

23 (F) Fourteen days before and thirty days after a special legislative
24 election OR MAJOR POLITICAL PARTY VACANCY ELECTION CONDUCTED
25 PURSUANT TO SECTION 1-12-203 (1.5) held in an off-election year.".

26 Page 14, line 9, after "RECEIVED" insert "AND EXPENDITURES MADE".

27 Page 14, strike lines 11 through 13 and substitute "DURING THE ELECTION
28 CYCLE FOR THE VACANCY COMMITTEE SELECTION PROCESS USED TO FILL
29 A VACANCY IN THE GENERAL ASSEMBLY PURSUANT TO SECTION
30 1-12-203.".

31 Page 14, strike lines 14 to 24.
