HB25-1315 be amended as follows:

1 Amend printed bill, page 11, line 21, strike "(2);" and substitute "(2) and
2 (8);".

3 Page 11, line 25, after "Candidate" insert "~~shall have~~".

4 Page 11, line 27, after "INCLUDES" insert "A CANDIDATE FOR A MAJOR
5 POLITICAL PARTY VACANCY ELECTION CONDUCTED PURSUANT TO SECTION
6 1-12-203 (1.5) AND".

7 Page 12, after line 12 insert:

8 "(8) "Election cycle" ~~shall have~~ HAS the same meaning as set forth
9 in section 2 (6) of article XXVIII of the state constitution; EXCEPT THAT:

10 (a) FOR A VACANCY COMMITTEE SELECTION PROCESS USED TO FILL
11 A VACANCY IN THE GENERAL ASSEMBLY PURSUANT TO SECTION 1-12-203,
12 "ELECTION CYCLE" MEANS THE PERIOD BEGINNING ON THE EFFECTIVE
13 DATE OF THE VACANCY IN THE GENERAL ASSEMBLY AND ENDING THIRTY
14 DAYS FOLLOWING THE DATE UPON WHICH THE VACANCY COMMITTEE
15 SELECTS AN INDIVIDUAL TO FILL THE VACANCY; AND

16 (b) FOR MAJOR POLITICAL PARTY VACANCY ELECTIONS HELD
17 PURSUANT TO SECTION 1-12-203 (1.5), "ELECTION CYCLE" MEANS THE
18 PERIOD BEGINNING ON THE DATE UPON WHICH A VACANCY COMMITTEE
19 SELECTS A MEMBER TO FILL THE VACANCY IN THE GENERAL ASSEMBLY
20 PURSUANT TO 1-12-203, AND ENDING THIRTY DAYS FOLLOWING THE
21 MAJOR POLITICAL PARTY VACANCY ELECTION."

22 Page 12, line 21, strike "If A VACANCY CONTENDER DOES" and substitute
23 "A CANDIDATE COMMITTEE ESTABLISHED IN THE NAME OF A VACANCY
24 CONTENDER MAY ACCEPT FROM ANY ONE PERSON THE AGGREGATE
25 CONTRIBUTION LIMIT SPECIFIED IN SECTION 3 (1) OF ARTICLE XXVIII OF
26 THE STATE CONSTITUTION APPLICABLE TO THE OFFICE THE VACANCY
27 CONTENDER IS SEEKING AT ANY POINT DURING THE ELECTION CYCLE FOR
28 THE VACANCY COMMITTEE SELECTION PROCESS USED TO FILL A VACANCY
29 IN THE GENERAL ASSEMBLY PURSUANT TO SECTION 1-12-203."

30 Page 12, strike lines 22 through 27.
