

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB22-196 be amended as follows:

- 1 Amend reengrossed bill, page 17, line 14, strike "AN OPIOID" and  
2 substitute "A SUBSTANCE".
- 3 Page 17, line 15, strike "SETTINGS" and substitute "SETTINGS, INCLUDING  
4 PROBATION,".
- 5 Page 17, line 18, strike "OPIOID" and substitute "A SUBSTANCE".
- 6 Page 18, strike lines 7 through 10 and substitute "ADMINISTRATIVE  
7 EXPENSES. THE JUDICIAL DEPARTMENT SHALL ALLOCATE ONE MILLION  
8 EIGHT HUNDRED THOUSAND DOLLARS OF THE MONEY APPROPRIATED  
9 PURSUANT TO THIS SUBSECTION (11) TO RECIPIENTS THAT PROVIDE  
10 DIVERSION FOR INDIVIDUALS WITH BEHAVIORAL HEALTH DISORDERS.".
- 11 Page 19, line 6, strike "HEALTH" and substitute "HEALTH, HOUSING, AND  
12 DEMOGRAPHIC".
- 13 Page 19, strike lines 11 through 17 and substitute "ONE-TIME GRANTS TO  
14 COUNTIES. EVERY COUNTY IS ELIGIBLE FOR A GRANT. A COUNTY THAT  
15 RECEIVES A GRANT SHALL USE THE GRANT MONEY TO:  
16 (I) INTEGRATE THE COUNTY JAIL'S DATA SYSTEMS WITH THE  
17 COLORADO INTEGRATED CRIMINAL JUSTICE INFORMATION SYSTEM;  
18 (II) STANDARDIZE CLIENT-SPECIFIC INFORMATION THROUGH  
19 COMMON DATA FIELDS RELATING TO THE BEHAVIORAL, MENTAL, AND  
20 PHYSICAL HEALTH NEEDS OF PERSONS DETAINED IN THE JAIL; HOUSING  
21 NEEDS FOR PERSONS FOLLOWING RELEASE FROM JAIL; AND DEMOGRAPHIC  
22 INFORMATION OF PERSONS DETAINED IN THE JAIL; AND  
23 (III) AUTOMATE DATA REPORTING REQUIRED PURSUANT TO STATE  
24 AND FEDERAL LAW.".
- 25 Page 19, line 19, strike "GRANTS, WHICH MUST INCLUDE ELIGIBILITY  
26 CRITERIA;" and substitute "GRANTS;".
- 27 Page 19, line 25, after "PUBLIC." insert "THE DIVISION SHALL PROVIDE,  
28 UPON REQUEST, ASSISTANCE TO COUNTIES WITH APPLYING FOR A GRANT.".
- 29 Page 20, lines 15 and 16, strike "ENTER INTO AN AGREEMENT WITH A  
30 THIRD-PARTY VENDOR" and substitute "COLLABORATE WITH THE OFFICE  
31 OF INFORMATION TECHNOLOGY, CREATED IN SECTION 24-37.5-103,".
