

SENATE COMMITTEE OF REFERENCE AMENDMENT
Committee on Judiciary.

SB22-196 be amended as follows:

1 Amend printed bill, page 6, lines 23 and 24, strike "UNDERGOING
2 COMPETENCY RESTORATION IN OUTPATIENT SETTINGS," and substitute
3 "ENGAGED IN COMPETENCY EVALUATION OR RESTORATION IN ANY
4 SETTING,".

5 Page 7, strike lines 8 through 11 and substitute:

6 "(c) TO FUND ENHANCED STAFFING, FACILITY IMPROVEMENTS, OR
7 SECURITY MEASURES FOR EXISTING CRISIS WALK-IN CENTERS, CRISIS
8 STABILIZATION UNITS, MOBILE CRISIS SERVICES, OR CRISIS RESPITE
9 SERVICES, AS DESCRIBED IN SECTION 27-60-103 (1)(b), AND WITHDRAWAL
10 MANAGEMENT PROGRAMS AT FACILITIES APPROVED PURSUANT TO ARTICLE
11 81 OF THIS TITLE 27. A CRISIS WALK-IN CENTER MUST USE A GRANT AWARD
12 TO ENABLE THE CRISIS WALK-IN CENTER TO ACCEPT ALL BEHAVIORAL
13 HEALTH RELATED FIRST RESPONDER DROP-OFFS AND PROVIDE CRISIS
14 RECEIVING AND STABILIZATION SERVICES. GRANTS AWARDED FOR CRISIS
15 STABILIZATION UNITS, MOBILE CRISIS SERVICES, CRISIS RESPITE SERVICES,
16 AND WITHDRAWAL MANAGEMENT PROGRAMS MUST BE USED TO".

17 Page 8, after line 5 insert:

18 "(g) TO SUPPORT, CREATE, OR EXPAND PROGRAMS TO HELP PEOPLE
19 WHO HAVE A PENDING MUNICIPAL CRIMINAL CASE ATTEND THEIR COURT
20 DATES AND AVOID JAIL FOR NON-APPEARANCE, SUCH AS THROUGH COURT
21 REMINDERS, RIDE ASSISTANCE, OR OTHER SUPPORTIVE INTERVENTIONS. A
22 PROGRAM THAT OPERATES WITH GRANT MONEY MUST SERVE A
23 SUBSTANTIAL NUMBER OF PEOPLE WITH BEHAVIORAL HEALTH NEEDS.".

24 Reletter succeeding paragraphs accordingly.

25 Page 9, line 25, strike "MATCHING RESOURCES" and substitute
26 "CONTRIBUTING FUNDS OR IN-KIND CONTRIBUTING RESOURCES".

27 Page 11, strike lines 20 through 22 and substitute:

28 "(3) THE BHA SHALL ONLY AWARD GRANTS TO APPLICANTS THAT
29 OFFER A MONETARY CONTRIBUTION OR IN-KIND CONTRIBUTIONS THAT
30 DIRECTLY SUPPORT THE SERVICES PROVIDED WITH A GRANT AWARD. IN
31 DETERMINING THE AMOUNT OF CONTRIBUTING RESOURCES REQUIRED FOR
32 AN APPLICANT, THE BHA SHALL CONSIDER THE SIZE OF THE APPLICANT
33 ORGANIZATION, INCLUDING AVAILABLE STAFF AND ANNUAL OPERATING
34 BUDGET. THE BHA MAY WAIVE THE CONTRIBUTING RESOURCES
35 REQUIREMENT FOR AN APPLICANT THAT IS REQUESTING A GRANT AWARD
36 OF LESS THAN FIFTY THOUSAND DOLLARS.".
