

## HOUSE FLOOR AMENDMENT

Second Reading

BY REPRESENTATIVE Lontine

1 Amend printed bill, page 3, line 25, strike "(1)(c)" and substitute "(1)(c);  
2 and **add** (3), (4), (5), and (6)".

3 Page 4, after line 12 insert:

4 "(3) A LICENSEE LICENSED UNDER THIS SECTION WHO PERFORMS  
5 LASER PROCEDURES OR TREATS OCULAR ADNEXA SHALL DEMONSTRATE  
6 COMPETENCY AND COMPLETE ONE OF THE FOLLOWING EDUCATION AND  
7 EXAMINATION REQUIREMENTS PRIOR TO PERFORMING THESE PROCEDURES:

8 (a) GRADUATE FROM AN ACCREDITED COLLEGE OR UNIVERSITY OF  
9 OPTOMETRY IN 2019 OR LATER WHERE THE LASER PROCEDURES AND  
10 OCULAR ADNEXA TREATMENTS WERE TAUGHT AND DEMONSTRATE  
11 PASSAGE OF THE STANDARDIZED NATIONAL EXAMINATION APPROVED BY  
12 THE BOARD PURSUANT TO SUBSECTION (1)(c) OF THIS SECTION; OR

13 (b) COMPLETE A TRAINING COURSE APPROVED BY THE BOARD AND  
14 SATISFACTORILY COMPLETE A PROCTORED CLINICAL SESSION WITHIN TWO  
15 YEARS PRIOR TO PERFORMING LASER PROCEDURES OR TREATING OCULAR  
16 ADNEXA. PROCTORING MAY BE PERFORMED BY AN OPTOMETRIST OR  
17 OPHTHALMOLOGIST LICENSED TO PERFORM THE PROCEDURES IN ANY  
18 JURISDICTION.

19 (4) IF A LICENSEE HAS NOT PERFORMED A LASER PROCEDURE  
20 WITHIN THE PAST TWO YEARS, THE LICENSEE SHALL SATISFACTORILY  
21 COMPLETE ANOTHER PROCTORED CLINICAL SESSION PRIOR TO PERFORMING  
22 ANY LASER PROCEDURES.

23 (5) A LICENSEE PERFORMING THE PROCEDURES DESCRIBED IN  
24 SUBSECTION (3) OF THIS SECTION SHALL REPORT TO THE BOARD ANY  
25 ADVERSE OUTCOMES FOLLOWING EACH PROCEDURE. THE LICENSEE SHALL  
26 DELIVER SUCH REPORTS AND ANY CORRESPONDING PATIENT RECORDS TO  
27 THE BOARD OFFICE WITHIN TEN DAYS AFTER THE DATE THAT THE LICENSEE  
28 IS AWARE OF THE ADVERSE OUTCOME.

29 (6) A LICENSEE SHALL MAINTAIN DOCUMENTATION EVIDENCING  
30 COMPLETION OF THE REQUIREMENTS OF SUBSECTIONS (3), (4), AND (5) OF  
31 THIS SECTION AND SHALL PROVIDE THE DOCUMENTATION TO THE BOARD  
32 UPON REQUEST. PERFORMING ANY OF THE PROCEDURES DESCRIBED IN  
33 SUBSECTION (3) OF THIS SECTION WITHOUT MEETING THE REQUIREMENTS  
34 OF SUBSECTIONS (3), (4), AND (5) OF THIS SECTION MAY SUBJECT THE  
35 LICENSEE TO DISCIPLINE BY THE BOARD PURSUANT TO SECTION  
36 12-275-122."
