

## HOUSE FLOOR AMENDMENT

Second Reading

1 Amend the Business Affairs & Labor Committee report, dated April 28,  
2 2022, page 1, line 1, strike ""EIGHT"." and substitute ""NINE".".

3 Page 1 of the committee report, strike lines 2 through 6 and substitute:

4 "Page 2 of the printed bill, line 14, strike "ASSOCIATION," and substitute  
5 "ASSOCIATION OF AMERICA,".

6 Page 2 of the bill, strike lines 17 through 19 and substitute:

7 "(d) ONE MEMBER RECOMMENDED BY CONSENSUS FROM A  
8 COALITION OF STATEWIDE LABOR ORGANIZATIONS ACTIVELY INVOLVED IN  
9 REPRESENTING THE WORK FORCE WITHIN PRODUCTION, APPOINTED BY THE  
10 EXECUTIVE DIRECTOR OF THE OFFICE OF ECONOMIC DEVELOPMENT. A  
11 STATEWIDE LABOR ORGANIZATION IS A STATE-LEVEL ORGANIZATION WITH  
12 MULTIPLE AFFILIATES IN THE STATE OR AN ORGANIZATION THAT HAS  
13 JURISDICTION FOR THE ENTIRE STATE.

14 (e) ONE MEMBER RECOMMENDED BY CONSENSUS FROM A  
15 COALITION OF STATEWIDE LABOR ORGANIZATIONS ACTIVELY INVOLVED IN  
16 REPRESENTING THE WORK FORCE WITHIN THE INDUSTRY TALENT AND  
17 ON-CAMERA PERFORMERS, APPOINTED BY THE EXECUTIVE DIRECTOR OF  
18 THE OFFICE OF ECONOMIC DEVELOPMENT. A STATEWIDE LABOR  
19 ORGANIZATION IS A STATE-LEVEL ORGANIZATION WITH MULTIPLE  
20 AFFILIATES IN THE STATE OR AN ORGANIZATION THAT HAS JURISDICTION  
21 FOR THE ENTIRE STATE.

22 (f) ONE REPRESENTATIVE FROM A BUSINESS SCHOOL IN A  
23 COLORADO INSTITUTION OF HIGHER EDUCATION, APPOINTED BY THE  
24 EXECUTIVE DIRECTOR OF THE OFFICE OF ECONOMIC DEVELOPMENT;  
25 AND".

26 Page 1 of the committee report, after line 7 insert:

27 "Page 3 of the bill, line 9, strike "MAY" and substitute "SHALL".
