

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Insurance.

HB19-1312 be amended as follows:

1 Amend corrected printed bill, page 6, strike lines 6 through 13 and  
2 substitute:

3        "(III) A LICENSED PHYSICIAN, PHYSICIAN ASSISTANT AUTHORIZED  
4 PURSUANT TO SECTION 12-36-106 (5), OR ADVANCED PRACTICE NURSE  
5 SHALL INFORM THE PARENT OR LEGAL GUARDIAN OF THE OPTION TO  
6 INCLUDE THE STUDENT'S IMMUNIZATION INFORMATION AND DATA IN THE  
7 IMMUNIZATION TRACKING SYSTEM CREATED IN SECTION 25-4-2403. A  
8 LICENSED PHYSICIAN, PHYSICIAN ASSISTANT AUTHORIZED PURSUANT TO  
9 SECTION 12-36-106 (5), OR ADVANCED PRACTICE NURSE SHALL NOT  
10 SUBMIT THE STUDENT'S IMMUNIZATION INFORMATION AND DATA TO THE  
11 IMMUNIZATION TRACKING SYSTEM WITHOUT THE STUDENT'S PARENT'S OR  
12 LEGAL GUARDIAN'S CONSENT.".

13 Page 7, strike lines 26 and 27 and substitute:

14        (III) THE DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT OR  
15 THE APPLICABLE COUNTY, DISTRICT, OR MUNICIPAL HEALTH AGENCY  
16 SHALL INFORM THE PARENT OR LEGAL GUARDIAN OF THE OPTION TO  
17 INCLUDE THE STUDENT'S IMMUNIZATION INFORMATION AND DATA IN THE  
18 IMMUNIZATION TRACKING SYSTEM CREATED IN SECTION 25-4-2403. THE  
19 APPLICABLE COUNTY, DISTRICT, OR MUNICIPAL HEALTH AGENCY SHALL  
20 NOT SUBMIT THE STUDENT'S IMMUNIZATION INFORMATION AND DATA TO  
21 THE IMMUNIZATION TRACKING SYSTEM WITHOUT THE STUDENT'S  
22 PARENT'S, LEGAL GUARDIAN'S, OR THE STUDENT'S, AS DESCRIBED IN  
23 SUBSECTION (2)(b)(I) OF THIS SECTION, CONSENT.".

24 Page 10, line 14, strike "SYSTEM." and substitute "SYSTEM, ONLY WITH  
25 THE STUDENT'S PARENT'S OR LEGAL GUARDIAN'S CONSENT.".
