HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Business Affairs & Labor.

HB26-1263 be amended as follows:

1 Amend printed bill, page 2, line 9, after "THROUGH" insert "ADAPTIVE".

2 Page 2, strike line 10 and substitute "COMMUNICATIONS AND USES
3 EMOTIONAL RECOGNITION ALGORITHMS TO RECOGNIZE, INTERPRET, OR
4 RESPOND TO HUMAN EMOTIONS."

5 Page 3, strike line 3 and substitute "PROGRAM THAT DOES NOT UTILIZE
6 EMOTIONAL RECOGNITION ALGORITHMS AND THAT:"

7 Page 3, strike lines 6 through 8 and substitute:

8 "(II) IS PRIMARILY DESIGNED TO PROVIDE COMMERCE-RELATED OR
9 TRANSACTIONAL ASSISTANCE, INCLUDING PRODUCT OR SERVICE
10 RECOMMENDATIONS, SHOPPING, ORDERING, PAYMENTS, DELIVERY,
11 RETURNS, CUSTOMER SUPPORT, OR CUSTOMER SERVICE;"

12 Page 3, line 12, strike "ENTITIES;" and substitute "ENTITIES FOR THE
13 PURPOSE OF BUSINESS OPERATIONS, PRODUCTIVITY, INFORMATION
14 ANALYSIS, INTERNAL RESEARCH, TRAINING, OR TECHNICAL ASSISTANCE;"

15 Page 3, line 15, strike "OR".

16 Page 3, line 16, strike "PURPOSES." and substitute "PURPOSES;

17 (VII) IS PRIMARILY DESIGNED FOR ASSISTING OR SUPPORTING
18 PATIENT OR RESIDENT CARE SERVICES IN A FACILITY AND COMPLIES WITH
19 HIPAA PRIVACY AND SECURITY REQUIREMENTS;

20 (VIII) IS A FEATURE OF A VIDEO GAME THAT IS LIMITED TO
21 DIALOGUE FOCUSED ON THE VIDEO GAME AND DOES NOT MAINTAIN
22 DIALOGUE ON TOPICS UNRELATED TO THE VIDEO GAME; OR

23 (IX) IS A FEATURE OF A THEME PARK OR LOCATION-BASED
24 ENTERTAINMENT AND IS LIMITED IN DIALOGUE TO TOPICS SOLELY RELATED
25 TO THE THEME PARK OR LOCATION-BASED ENTERTAINMENT AND DOES NOT
26 MAINTAIN A DIALOGUE ABOUT TOPICS UNRELATED TO THE THEME PARK OR
27 LOCATION-BASED ENTERTAINMENT."
