

## HOUSE FLOOR AMENDMENT

Second Reading

1 Amend printed bill, page 3, strike line 5 and substitute:

2 "(9), (10), and (11) as follows:"

3 Page 12, line 20, strike " GOVERNMENT, TRIBAL GOVERNMENT," and  
4 substitute "GOVERNMENT".

5 Page 13, line 9, strike "GOVERNMENT'S OR TRIBAL".

6 Page 13, lines 22 and 23, strike "OR A TRIBAL GOVERNMENT".

7 Page 14, after line 26 insert:

8 "(11) BEGINNING IN 2027, TO BE ELIGIBLE UNDER THIS ARTICLE 32  
9 FOR DIRECT FUNDING, OR FOR AFFORDABLE HOUSING PROJECTS WITHIN A  
10 TRIBAL GOVERNMENT'S TERRITORIAL BOUNDARIES TO BE ELIGIBLE UNDER  
11 THIS ARTICLE 32 FOR FUNDING, TRIBAL GOVERNMENTS SHALL SATISFY THE  
12 REQUIREMENTS OF SUBSECTION (2) OF THIS SECTION TO IMPLEMENT A  
13 SYSTEM TO EXPEDITE THE DEVELOPMENT APPROVAL PROCESS FOR  
14 AFFORDABLE HOUSING PROJECTS AND SHALL SUBMIT EVIDENCE OF SUCH  
15 SATISFACTION TO THE DIVISION."

16 Strike "government or tribal" and substitute "~~government or tribal~~" on:  
17 **Page 3**, line 12; **Page 4**, line 1; **Page 7**, lines 4, 11, 12, and 27; and **Page**  
18 **9**, line 4.

19 Strike "GOVERNMENT OR TRIBAL" on: **Page 4**, lines 25 and 27; **Page 5**,  
20 lines 5, 11, and 17; **Page 10**, lines 1, 8, and 25; **Page 11**, lines 14 and 20;  
21 **Page 12**, line 21; **Page 13**, line 16; and **Page 14**, lines 4 and 13.

22 Strike "governments and tribal" and substitute "~~governments and tribal~~"  
23 on: **Page 7**, line 20; **Page 8**, line 27; and **Page 9**, lines 1 and 18.

24 Strike "government's or tribal" and substitute "~~government's or tribal~~" on:  
25 **Page 8**, lines 12, 13, and 19.

26 Strike "OR A TRIBAL GOVERNMENT" on: **Page 9**, line 21; **Page 11**, line 23;  
27 and **Page 12**, lines 3 and 7;
