

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Energy.

SB25-182 be amended as follows:

1 Amend printed bill, page 2, after line 1 insert:

2 "SECTION 1. **Legislative declaration.** (1) The general  
3 assembly finds and declares that nothing in Senate Bill 25-182 impacts  
4 the ability of a local governmental entity to review or approve eligible  
5 materials for installations or modifications to real property."

6 Renumber succeeding sections accordingly.

7 Page 2, strike lines 7 through 10 and substitute "INSTALLATIONS OR  
8 MODIFICATIONS TO REAL PROPERTY USING ELIGIBLE MATERIALS, AS  
9 DEFINED IN SECTION 24-92-118 (2)(b), THAT RESULT IN THE REDUCTION  
10 OF THE INSTALLATION'S OR MODIFICATION'S EMBODIED EMISSIONS AS  
11 ESTABLISHED IN POLICIES CREATED BY THE COLORADO ENERGY OFFICE,  
12 CREATED IN SECTION 24-38.5-101, AND IN CONSULTATION WITH THE  
13 OFFICE OF THE STATE ARCHITECT."

14 Page 2, line 18, before "(2)(e)(XVIII);" insert "(2)(e) introductory portion  
15 and".

16 Page 3, line 2, strike "and retrofits:" and substitute "~~and retrofits~~  
17 RETROFITS, OR INVESTMENTS:".

18 Page 3, strike lines 7 through 16 and substitute "JANUARY 1, 2026,  
19 EMBODIED CARBON INVESTMENTS, WHICH ARE INVESTMENTS IN THE  
20 PRODUCTION OF ELIGIBLE MATERIALS, AS DEFINED IN SECTION 24-92-118  
21 (2)(b), THAT RESULT IN THE REDUCTION OF THE ELIGIBLE MATERIALS'  
22 CRADLE-TO-GATE EMBODIED EMISSIONS, AS ESTABLISHED IN POLICIES  
23 CREATED BY THE COLORADO ENERGY OFFICE, CREATED IN SECTION  
24 24-38.5-101, AND IN CONSULTATION WITH THE OFFICE OF THE STATE  
25 ARCHITECT. TO QUALIFY AS AN EMBODIED CARBON INVESTMENT, AN  
26 INVESTMENT MUST RESULT IN A FIFTEEN PERCENT OR GREATER REDUCTION  
27 IN CRADLE-TO-GATE EMBODIED EMISSIONS OF THE ELIGIBLE MATERIALS  
28 WHEN COMPARED TO THE ELIGIBLE MATERIALS' CRADLE-TO-GATE  
29 BASELINE AS ESTABLISHED IN STANDARDS AND GUIDELINES CREATED BY  
30 THE COLORADO ENERGY OFFICE AND IN CONSULTATION WITH THE OFFICE  
31 OF THE STATE ARCHITECT. A CRADLE-TO-GATE MEASUREMENT OR  
32 BASELINE CONSIDERS THE LIFE CYCLE STAGES FOR A PRODUCT INCLUDING,  
33 BUT NOT LIMITED TO, THE RAW MATERIAL EXTRACTION AND PROCESSING  
34 RELATED TO THE PRODUCT, AND THE TRANSPORT TO THE MANUFACTURER  
35 AND MANUFACTURING OF THE PRODUCT."
