Second Reading

2 before line 1 insert:  
  
3 "Amend reengrossed bill, page 4, line 22, strike "GOVERNOR;" and  
4 substitute "EXECUTIVE DIRECTOR, OR THE EXECUTIVE DIRECTOR'S  
5 DESIGNEE;".
- 6 Page 4 of the bill, line 24, strike "GOVERNOR;" and substitute "DIRECTOR,  
7 OR THE DIRECTOR'S DESIGNEE;".
- 8 Page 5 of the bill, line 5, strike "GOVERNOR;" and substitute "GOVERNOR,  
9 ON THE ADVICE OF A STATEWIDE STUDENT COALITION;".
- 10 Page 5 of the bill, line 10, strike "SENATE;" and substitute "SENATE, ON  
11 THE ADVICE OF A STATEWIDE ASSOCIATION THAT REPRESENTS  
12 SUPERINTENDENTS OF PUBLIC SCHOOLS;".
- 13 Page 1 of the report, line 1, strike "Amend reengrossed bill, page 5," and  
14 substitute "Page 5 of the bill,".
- 15 Page 1 of the report, line 2, strike "OR THEIR RESPECTIVE DESIGNEES,".
- 16 Page 1 of the report, line 6, strike "REPRESENTATIVES;." and substitute  
17 "REPRESENTATIVES, ON THE ADVICE OF A STATEWIDE ASSOCIATION THAT  
18 REPRESENTS SCHOOL ADMINISTRATORS;".
- 19 Page 1 of the report, after line 6 insert:  
  
20 "Page 5 of the bill, line 15, after "SENATE," insert "ON THE ADVICE OF A  
21 STATEWIDE PROFESSIONAL ASSOCIATION THAT REPRESENTS THE GREATEST  
22 PROPORTION OF EDUCATORS IN THE STATE, ".
- 23 Page 5 of the bill, line 16, strike "AN URBAN" and substitute "A RURAL".
- 24 Page 5 of the bill, line 17, strike "REPRESENTATIVES;" and substitute  
25 "REPRESENTATIVES, ON THE ADVICE OF A STATEWIDE ORGANIZATION THAT  
26 REPRESENTS ONLY RURAL SCHOOL DISTRICTS;".
- 27 Page 5 of the bill, line 18, strike "NURSE OR PEDIATRICIAN," and substitute  
28 "NURSE,".

1 Page 5 of the bill, line 19, strike "REPRESENTATIVES;" and substitute  
2 "REPRESENTATIVES, ON THE ADVICE OF A STATEWIDE PROFESSIONAL  
3 ASSOCIATION THAT REPRESENTS SCHOOL NURSES;".

4 Page 5 of the bill, strike lines 20 through 24 and substitute:

5 "(E) A CHILD DEVELOPMENT PROFESSIONAL, APPOINTED BY THE  
6 MINORITY LEADER OF THE SENATE, ON THE ADVICE OF A STATEWIDE  
7 ORGANIZATION COMPRISED OF MEDICAL PROFESSIONALS BOARDED OR  
8 CERTIFIED IN PEDIATRICS;

9 (F) A BEHAVIORAL HEALTH PROFESSIONAL, APPOINTED BY THE  
10 BEHAVIORAL HEALTH COMMISSIONER;

11 (G) A PROFESSIONAL SPECIALIZING IN TRAUMA-INFORMED  
12 PRACTICES, APPOINTED BY THE OFFICE;".

13 Reletter succeeding sub-subparagraphs accordingly.

14 Page 5 of the bill, lines 25 and 26, strike "OR LOCAL LAW ENFORCEMENT  
15 REPRESENTATIVE".

16 Page 5 of the bill, line 27, strike "THE MINORITY LEADER OF THE SENATE;"  
17 and substitute "THE MINORITY LEADER OF THE SENATE, ON THE ADVICE OF  
18 A STATEWIDE ASSOCIATION OF COUNTY SHERIFFS;".

19 Page 6 of the bill, line 2, strike "PRESIDENT OF THE SENATE;" and  
20 substitute "EXECUTIVE DIRECTOR OF THE DEPARTMENT OF PUBLIC HEALTH  
21 AND ENVIRONMENT;".

22 Page 6 of the bill, strike line 5 and substitute "DIRECTOR OF THE DIVISION  
23 OF FIRE PREVENTION AND CONTROL;".

24 Page 6 of the bill, line 8, strike "REPRESENTATIVES;" and substitute  
25 "REPRESENTATIVES, ON THE ADVICE OF A STATEWIDE PARENT  
26 ORGANIZATION THAT FOCUSES ON EDUCATION POLICY;".
