

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

SB25-027 be amended as follows:

1 Amend printed bill, page 3, line 11, after "**membership** -" add "**fund** -".

2 Page 4, line 11, strike "IMMIGRATION STATUS,".

3 Page 7, strike lines 20 through 23 and substitute:

4 "(d) A MAJORITY OF THE MEMBERS APPOINTED TO THE WORK  
5 GROUP CONSTITUTES A QUORUM. IF THE WORK GROUP IS UNABLE TO  
6 REACH A QUORUM DUE TO UNFORESEEN CIRCUMSTANCES, THE WORK  
7 GROUP MAY PROCEED WITH A REDUCED QUORUM OF NO FEWER THAN SIX  
8 VOTING MEMBERS."

9 Page 9, after line 27 insert:

10 "(8) THE OFFICE MAY SEEK, ACCEPT, AND EXPEND GIFTS, GRANTS,  
11 OR DONATIONS FROM PRIVATE OR PUBLIC SOURCES FOR THE PURPOSES OF  
12 THIS SECTION. THE OFFICE SHALL TRANSMIT ALL MONEY RECEIVED  
13 THROUGH GIFTS, GRANTS, OR DONATIONS TO THE STATE TREASURER, WHO  
14 SHALL CREDIT THE MONEY TO THE TRAUMA-INFORMED PRACTICES FOR  
15 SCHOOL SAFETY DRILLS FUND CREATED IN SUBSECTION (9) OF THIS  
16 SECTION.

17 (9) THE TRAUMA-INFORMED PRACTICES FOR SCHOOL SAFETY  
18 DRILLS FUND IS CREATED IN THE STATE TREASURY. THE  
19 TRAUMA-INFORMED PRACTICES FOR SCHOOL SAFETY DRILLS FUND  
20 CONSISTS OF GIFTS, GRANTS, OR DONATIONS CREDITED TO THE FUND  
21 PURSUANT TO SUBSECTION (8) OF THIS SECTION AND ANY OTHER MONEY  
22 THAT THE GENERAL ASSEMBLY MAY APPROPRIATE OR TRANSFER TO THE  
23 FUND. THE STATE TREASURER SHALL CREDIT ALL INTEREST AND INCOME  
24 DERIVED FROM THE DEPOSIT AND INVESTMENT OF MONEY IN THE  
25 TRAUMA-INFORMED PRACTICES FOR SCHOOL SAFETY DRILLS FUND TO THE  
26 FUND."
