1 Amend the Energy and Environment Committee Report, dated April 14,
2 2022, page 2, after line 27 insert:

3 "Page 8, after line 10 insert:

4 "(5) (a) THE DIRECTOR OF THE COLORADO ENERGY OFFICE SHALL
5 APPOINT AND CONVENE AN ENERGY CODE ADVISORY BOARD.

6 (b) NO LATER THAN OCTOBER 1, 2022, THE ENERGY CODE
7 ADVISORY BOARD SHALL IDENTIFY A MODEL ELECTRIC READY AND SOLAR
8 READY CODE FOR ADOPTION BY COUNTIES, MUNICIPALITIES, AND STATE
9 AGENCIES.

10 (c) NO LATER THAN JUNE 30, 2023, THE ENERGY CODE ADVISORY
11 BOARD SHALL IDENTIFY A MODEL LOW ENERGY AND LOW CARBON CODE
12 FOR ADOPTION BY COUNTIES, MUNICIPALITIES, AND STATE AGENCIES.

13 (d) IN ORDER FOR THE ENERGY CODE ADVISORY BOARD TO
14 IDENTIFY AN ENERGY CODE PURSUANT TO EITHER SUBSECTION (5)(b) OR
15 (5)(c) OF THIS SECTION, THE DEPARTMENT OF LOCAL AFFAIRS AND THE
16 COLORADO ENERGY OFFICE MUST FIRST VERIFY THAT THE ENERGY CODES
17 IDENTIFIED FOR ADOPTION COMPLY WITH THE STATUTORY INTENT OF
18 HOUSE BILL 22-1362.

19 (d) (I) THE ADVISORY BOARD SHALL SUNSET SEPTEMBER 1, 2027.

20 (II) PRIOR TO THE REPEAL OF THIS SECTION, THE DEPARTMENT OF
21 REGULATORY AGENCIES SHALL CONDUCT A SUNSET REVIEW AS DESCRIBED
22 IN SECTION 24-34-104 (5)".

24 Page 5, after line 10 insert:

25 "Page 32, after line 17:

26 **SECTION 13.** In Colorado Revised Statutes, 24-34-104, **add**
27 (28)(a)(VII) as follows:

28 **24-34-104. General assembly review of regulatory agencies**
29 **and functions for repeal, continuation, or reestablishment - legislative**
30 **declaration - repeal.** (28) (a) The following agencies, functions, or both,
31 are scheduled for repeal on September 1, 2027:

32 (VII) THE ENERGY CODE ADVISORY BOARD CREATED PURSUANT TO
33 SECTION 24-38.5-113 (5)";
