5 ADOPTED AND ENFORCED ONE OR MORE BUILDING CODES, AND THAT
6 UPDATES ONE OR MORE BUILDING CODES ON OR AFTER JULY 1, 2023, AND
7 BEFORE JULY 1, 2026, SHALL ADOPT AND ENFORCE AN ENERGY CODE THAT
8 ACHIEVES EQUIVALENT OR BETTER ENERGY PERFORMANCE THAN THE 2021
9 INTERNATIONAL ENERGY CONSERVATION CODE AND THE MODEL ELECTRIC
10 READY AND SOLAR READY CODE LANGUAGE IDENTIFIED FOR ADOPTION BY
11 THE ENERGY CODE ADVISORY BOARD PURSUANT TO SECTION 24-38.5-113
12 (5)(b), AT THE SAME TIME OTHER BUILDING CODES ARE UPDATED.

13 (b) A BOARD OF COUNTY COMMISSIONERS THAT HAS ADOPTED AND
14 ENFORCED ONE OR MORE BUILDING CODES, AND THAT UPDATES ONE OR
15 MORE BUILDING CODES ON OR AFTER JULY 1, 2026, SHALL ADOPT AND
16 BEGIN ENFORCING AN ENERGY CODE THAT ACHIEVES EQUIVALENT OR
17 BETTER ENERGY AND CARBON EMISSIONS PERFORMANCE THAN THE MODEL
18 LOW ENERGY AND CARBON CODE IDENTIFIED FOR ADOPTION BY THE
19 ENERGY CODE ADVISORY BOARD PURSUANT TO SECTION 24-38.5-113
20 (5)(c), AT THE SAME TIME OTHER BUILDING CODES ARE UPDATED.

21 (c) WHEN ADOPTING OR UPDATING A BUILDING CODE PRIOR TO
22 JULY 1, 2023, A BOARD OF COUNTY COMMISSIONERS SHALL ADOPT AND
23 ENFORCE AN ENERGY CODE THAT ACHIEVES EQUIVALENT OR BETTER
24 ENERGY PERFORMANCE THAN ONE OF THE THREE MOST RECENT EDITIONS
25 OF THE INTERNATIONAL ENERGY CONSERVATION CODE."
