

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB22-1362 be amended as follows:

1 Amend printed bill, page 15, line 7 strike "AND".

2 Page 15, strike line 10 and substitute:

3 "EQUIPMENT; AND

4 (c) IN THE CASE OF LOCAL GOVERNMENTS, ELECTRIC AND GAS  
5 UTILITIES, NONPROFIT ORGANIZATIONS, BUSINESSES AND OTHER ENTITIES  
6 AS DETERMINED BY THE COLORADO ENERGY OFFICE, OR HOUSING  
7 DEVELOPERS THAT OPERATE IN LOW-INCOME, DISPROPORTIONATELY  
8 IMPACTED COMMUNITIES, OR JUST TRANSITION COMMUNITIES AS THOSE  
9 COMMUNITIES ARE IDENTIFIED BY THE COLORADO ENERGY OFFICE, TO  
10 COVER THE ADMINISTRATIVE COSTS ASSOCIATED WITH THE PURCHASE AND  
11 INSTALLATION DESCRIBED IN SUBSECTIONS (3)(a) AND (3)(b) OF THIS  
12 SECTION.".

13 Page 15, line 17, after "OFFICE" insert "MAY DEVELOP POLICIES AND  
14 PROCEDURES PRIORITIZING THE GRANT APPLICATIONS OF LOCAL  
15 GOVERNMENTS, ELECTRIC AND GAS UTILITIES, NONPROFIT  
16 ORGANIZATIONS, BUSINESSES AND OTHER ENTITIES AS DETERMINED BY  
17 THE COLORADO ENERGY OFFICE, OR HOUSING DEVELOPERS THAT OPERATE  
18 IN LOW-INCOME, DISPROPORTIONATELY IMPACTED COMMUNITIES, OR JUST  
19 TRANSITION COMMUNITIES AS THOSE COMMUNITIES ARE IDENTIFIED BY  
20 THE COLORADO ENERGY OFFICE AND THE COLORADO ENERGY OFFICE".

21 Page 15, strike lines 20 through 24 and substitute "GRANT PROGRAM TO  
22 SUCH LOCAL GOVERNMENTS, ELECTRIC AND GAS UTILITIES, NONPROFIT  
23 ORGANIZATIONS, BUSINESSES AND OTHER ENTITIES AS DETERMINED BY  
24 THE COLORADO ENERGY OFFICE, OR HOUSING DEVELOPERS.".

25 Page 15, line 25, strike "(7)" and substitute "(7) (a)".

26 Page 16, after line 2 insert:

27 (b) THE COLORADO ENERGY OFFICE SHALL PROVIDE TECHNICAL  
28 ASSISTANCE IN APPLYING FOR GRANTS THROUGH THE BUILDING  
29 ELECTRIFICATION FOR PUBLIC BUILDINGS GRANT PROGRAM AS NEEDED TO  
30 LOCAL GOVERNMENTS, ELECTRIC AND GAS UTILITIES, NONPROFIT  
31 ORGANIZATIONS, BUSINESSES AND OTHER ENTITIES AS DETERMINED BY  
32 THE COLORADO ENERGY OFFICE, OR HOUSING DEVELOPERS THAT OPERATE  
33 IN LOW-INCOME, DISPROPORTIONATELY IMPACTED COMMUNITIES, OR JUST  
34 TRANSITION COMMUNITIES AS THOSE COMMUNITIES ARE IDENTIFIED BY  
35 THE COLORADO ENERGY OFFICE.".
