## HB 26-1264: SAFETY PROGRAM FOR STUDENTS & OTHERS AT PUBLIC SCHOOL

**Fiscal note status:** The final fiscal note reflects the introduced bill. This bill was postponed indefinitely by the House Education Committee on April 23, 2026; therefore, the impacts identified in this analysis do not take effect.

### Summary Information

**Overview.** The bill would have required school districts and charter schools to adopt certain school safety and student wellness policies and share information on the Safe2Tell program, and required that the state create a model message related to certain school safety topics.

**Types of impacts.** The bill would have affected the following areas on an ongoing basis:

- Minimal State Workload
- School Districts

**Appropriations.** No appropriation was required.

## Summary of Legislation

---

The bill requires certain policy updates and distribution of information related to student safety, as outlined below.

- Each school district and charter school must have a policy for receiving safety reports, conducting threat assessment, referring students to behavioral health supports, coordinating with law enforcement, and developing a support and reentry plan for students with safety-related incidents. The policy must include a student wellness response pathway that identifies behavioral health, crisis response, and support for students impacted by a traumatic event.
- The Department of Public Safety (CDPS) must draft a model message related to cybersecurity, online safety, safe firearm storage, and youth access to firearms prevention, to be made available at no cost to public and private schools.
- Public schools must annually provide students, parent or guardians, and staff with information on anonymous reporting through the Safe2Tell Program.

Each school district and charter school must certify compliance with the safety plan and student wellness pathway requirements on their website, and may submit it to the state through an existing mechanism. The bill specifies that the provisions do not require new expenditures for school districts or charter schools and must be done with available resources.

## State Expenditures

---

The bill increases workload for CDPS to create a model message that includes the specified topics and make it available to schools. Colorado Department of Education will have minimal workload to coordinate with CDPS on the message. The fiscal note assumes that neither CDPS or CDE is required to collect the district certifications and that it is optional for a district or school to submit it to the state.

Additionally, current law requires that the Department of Law provide materials on Safe2Tell to school districts and schools upon request. If more materials are requested in order to meet the bill's requirement that Safe2Tell information be distributed to students and parents, the Department of Law will have additional workload. Most materials are provided digitally; however, should physical materials be requested by schools, additional resources may be requested through the annual budget process.

## **School District**

---

Depending on existing school district policies, the bill may increase workload for school districts to ensure that district policies align with the bill’s requirements, share Safe2Tell information with families and staff, and certify compliance. The fiscal note assumes that most districts will modify existing school safety and student support plans to comply and are not required to create new programs.

## **Effective Date**

---

The bill takes effect upon signature of the Governor, or upon becoming law without his signature.
