SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Veterans, & Military Affairs.

SB17-304 be amended as follows:

1 Amend printed bill, page 4, after line 14 insert:

2 "SECTION 4. In Colorado Revised Statutes, 24-37-302, add  
3 (1)(a.5) as follows:

4 **24-37-302. Responsibilities of the office of state planning and**  
5 **budgeting.** (1) The office of state planning and budgeting shall assist the  
6 governor in his or her responsibilities pertaining to the executive budget.  
7 Specifically, it shall:

8 (a.5) DESIGN AND PREPARE, IN COORDINATION WITH THE STAFF OF  
9 THE JOINT TECHNOLOGY COMMITTEE OF THE GENERAL ASSEMBLY, THE  
10 FORMS AND INSTRUCTIONS TO BE USED IN PREPARATION OF ALL BUDGET  
11 REQUESTS AND SUPPLEMENTAL BUDGET REQUESTS SUBMITTED TO THE  
12 JOINT TECHNOLOGY COMMITTEE PURSUANT TO SECTION 24-37-304  
13 (1)(c.5). THE STAFF OF THE JOINT TECHNOLOGY COMMITTEE SHALL MAKE  
14 RECOMMENDATIONS TO THE JOINT TECHNOLOGY COMMITTEE REGARDING  
15 SUCH FORMS AND INSTRUCTIONS FOR THE COMMITTEE'S APPROVAL. THE  
16 FORMS AND INSTRUCTIONS SHALL REQUIRE THAT BUDGET REQUESTS  
17 SUBMITTED TO THE JOINT TECHNOLOGY COMMITTEE INCLUDE:

18 (I) INFORMATION FROM A REQUEST FOR INFORMATION ISSUED  
19 PURSUANT TO SECTION 24-103-201.5, OR OTHER FORMAL MARKET  
20 RESEARCH REGARDING THE INFORMATION TECHNOLOGY BUDGET REQUEST;

21 (II) A DEFINED SCOPE OF WORK AND INFORMATION REGARDING  
22 WHETHER A VENDOR OR CONSULTANT ASSISTED IN PREPARING THE  
23 SPECIFICATIONS OR STATEMENT OF WORK INCLUDED IN THE INFORMATION  
24 TECHNOLOGY BUDGET REQUEST;

25 (III) A RANGE OF OPTIONS FOR COMPLETING THE PROJECT,  
26 INCLUDING THE ESTIMATED COSTS FOR SUCH OPTIONS; AND

27 (IV) ANY OTHER AVAILABLE AND RELEVANT INFORMATION  
28 OBTAINED FROM THE MARKET RESEARCH RELATED TO THE INFORMATION  
29 TECHNOLOGY BUDGET REQUEST."

30 Renumber succeeding section accordingly.
