Dear Chair Woodrow, Vice Chair Titone, and Members of the Committee,

My name is Rorey King, and I am writing on behalf of United Way of Larimer County in strong support of HB26-1221, HB26-1222, and HB26-1223. These bills decouple Colorado's tax code from certain federal provisions created through H.R. 1, remove the downloadable software tax exemption, and establish the Family Affordability Credit. Together, they help ensure that low-income families with children continue to receive the critical financial support provided through the Family Affordability Tax Credit, especially during times of state budget deficits and economic uncertainty, and prevent corporate tax benefits from coming at the expense of families.

At United Way of Larimer County, we believe that every young person should have what they need to thrive. From advancing family financial stability and expanding access to quality child care to strengthening the foundations for high school graduation, our work focuses on removing the barriers that keep families living paycheck to paycheck and prevent young people from reaching their full potential. Providing and advocating for reliable, flexible financial support for low-income families with children is central to that mission.

One way we do this is through our WomenGive program, which covers the cost of child care for single mothers pursuing higher education and provides monthly cash assistance to program graduates during the year following graduation. Every WomenGive recipient qualifies for the Family Affordability Tax Credit. When asked about the credit, one graduate shared that when she filed her taxes in April 2025, she received more than \$7,000 back from the state. Without that support, she wasn't sure how she would have made ends meet. The credit helped cover rent and basic expenses, allowing her to stay enrolled in school and sustain herself and her three children through her final semester and the summer that followed.

This recipient's experience aligns with our data; according to the Colorado ALICE report, nearly 30% of single-woman-led households with children under 18 live in poverty, and an additional 25% live above the federal poverty level but still struggle to afford basic necessities. Tax credits like the Family Affordability Tax Credit helped reduce child poverty in Colorado by 40.5%. However, due to the state's current budget deficit, this support is at risk.

United Way of Larimer County supports the solution presented through the 2026 Tax Package, which ensures that federal tax benefits for corporations do not result in the loss of essential support for our WomenGive recipients and for low-income families with children across Colorado. With the cost of living continuing to rise in Colorado and public assistance benefits being stripped away at the federal level, it is critical that we protect the strides that we have made as a state, like the Family Affordability Tax Credit, to make life more affordable and accessible for working families.

My name is Teronica Williams, and I am a parent of 3 children, a working parent, and a Parent Ambassador at Clayton Early Learning. I am here today to speak in support of House Bill 26-1222 and the importance of protecting the Family Affordability Tax Credit for families like mine.

Like many working families across Colorado, I work hard every day to support my children and provide them with stability and opportunity. Even with steady employment, it can still be challenging to keep up with the rising costs of mortgage, transportation, childcare, and everyday necessities. Many families are doing everything they can to stay afloat, but the cost of living continues to stretch our budgets thin.

The Family Affordability Tax Credit has made a meaningful difference in my family's life. This credit is not about getting ahead unfairly, it is about stability. It provides families like mine with the breathing room we need to keep up with essential expenses while still being able to invest in our children's growth and wellbeing.

For my family, this credit has helped cover important costs like school supplies, extracurricular activities, and childcare. When parents have a little more financial stability, we are better able to support our children in school, encourage their interests, and provide the opportunities that help them grow into successful adults.

As a working parent, knowing that support like this exists gives me peace of mind. It allows me to focus on my work and on raising my children without constantly worrying about how I will cover the next unexpected expense. Without this credit, many families like mine would feel the impact immediately. Losing this support would mean making harder choices between basic needs and opportunities that help our children thrive.

Policies like the Family Affordability Tax Credit recognize the reality that working families are doing their best every day to provide for their children. These credits help ensure that families are not left behind and that our tax system reflects the value we place on supporting children and working parents.
